**REGULATIONS FOR THE IMPORTATION OF MILK AND MILK PRODUCTS
INTO THE STATE OF SARAWAK, MALAYSIA
(Effective from 18th June 2019)**

- A. Products : Liquid milk, milk powder, cheese, butter, ice-cream or milk / dairy products thereof
B. Country of export : Any country or any State in Malaysia
C. Purpose : For Human Consumption

D. REGULATION FOR IMPORTATION

1. Import Permit

Each consignment of milk and milk products shall be accompanied by a valid import permit issued by the State Veterinary Authority, Department of Veterinary Services Sarawak permitting entry into Sarawak, Malaysia.

2. Veterinary Health Certification

Each consignment of milk and milk products shall be accompanied by Veterinary Health Certificate dated within thirty (30) days of import and signed or endorsed by competent veterinary officer of the Government Veterinary Authority of the country of exporting certifying that:-

2.1 the country or part of country or state of origin has been free from *Foot and Mouth disease, Rinderpest / Peste des petits ruminants, Contagious Bovine Plueropneumonia, Contagious Caprine Plueropneumonia* and *Bovine Encephalopathy* for the past twelve (12) months prior to and till the date of export;

2.2 the milk and milk products were derived from animals (cattle or goats) that have been examined, tested and certified to be free from *Tuberculosis* and have been domiciled in the country of export in the preceding twelve (12) months prior to export;

2.3 the animals were found to be healthy and free from any from any clinical sign of infectious or contagious disease (including ectoparasites) at the time of milking;

2.4 that the milk products originate from herds or flocks which were not subjected to any restrictions due to FMD at the time of milk collection;

2.5 that the milk has been subjected to one of the following procedures to inactivate the viruses present in milk and cream for human consumption, in accordance with Article 3.6.2.5 of the International Animal Health Code 2002.

- a. Ultra-high temperature (UHT) (UHT = minimum temperature of 132°C for least 1 second)
- b. If the milk has a pH less than 7.0, simple high temperature – short time pasteurisation (HTST);
- c. If milk has a pH of 7.0 or over, double HTST.

2.6 the necessary precautions were taken after processing to avoid contact of the products with any potential sources of FMD virus.

2.7 the milk and milk products were processed and packed in the processing or packing plant that has been approved for export with **Veterinary Health Mark Logo** issued by Department of Veterinary Services Malaysia (DVS) (the name, address and establishment number of the plant) and overseas plant/establishment approved by DVS Malaysia;

2.8 the milk and milk products were processed, packed and stored under sanitary condition and do not contain any preservative, colouring matter, residue or any foreign substance or harmful material injurious to health and that every precaution had been taken to prevent contamination during, the processing, packed, stocking and handling prior to export;

2.9 that the milk and milk products has been subjected to pasteurization, ultra-heat treatment or sterilization and was packed direct into satisfactory clean and sterilized bottle or container and fulfil the microbiological limits as stated in clause (7) in this permit;

2.10 that the milk or milk products destined for export to Sarawak, Malaysia are wholesome and fit for human consumption.

3. Transportation

Each consignment of milk and milk products imported into Sarawak, Malaysia shall be carried by ship or aircraft or any vehicle direct to the prescribed landing place in Malaysia.

4. Surrender of Official Document in Sarawak, Malaysia

Upon arrival upon in Sarawak, Malaysia, all official documents required under each importation shall be surrender for verification to the State Veterinary Authority or his representatives.

5. Other Conditions

5.1 All applications for importation of milk and milk products into Sarawak, Malaysia shall be made by writing direct to State Veterinary Authority, Department of Veterinary Services Sarawak. All importations must be through the local agent or a Malaysian registered company;

5.2 The State Veterinary Authority has the right to enquire for any document or detail information from the parties concerned. In the event that the applicants (importer or exporter) fail or unable to provide or to comply with any of the above requirements, the State Veterinary Authority has the right to reject or not to approve the application;

5.3 The processing or packing plant shall be subjected to inspection by the official(s) from the State Veterinary Authority prior to approval as and when deemed necessary. All costs incurred shall be borne by the parties concerned;

6. Failure to comply with any of the above conditions will result in the consignment being rejected on arrival or on inspection on board ship; the consignment shall not be landed and the importer shall bear the cost of sending the consignment back.

7. Microbiological Limit
